Leasing Process **Applicants are required to complete and submit an application with a \$50 application fee.**

All tenants are required to complete an Allegiance Real Estate application and submit with a \$50 application fee per person.

Screening Criteria. All rental applications will be screened for the following criteria: Rental application Must be complete, correct, and verified. Photo ID must be provided

Income Must be at least 3 times the monthly rent and verified with paystubs or income statements. Reference from previous landlord must be positive.

Credit history Must prove history of on-time payments for the following: Rental payments, phone bill payments, auto payments, school loan payments, utility payments

(with the exception of utility payments during the Covid-19 pandemic)

Before moving in all tenants must pay First month rent, last month rent and security deposit equal to one month rent unless otherwise stated.

A security deposit is required to reserve any rental. Once a deposit is received your rental will be removed from the open market. This initial deposit is NON-REFUNDABLE.

Once applicants have been approved and deposit paid a lease will be drafted and sent to all tenants and applicable co-signor's.

All payments required prior to move in must be paid at least 10 days prior to move in and made payable to "Allegiance Real Estate LLC"

NO PERSONAL CHECKS WILL BE ACCEPTED WITHIN 10 DAYS OF YOUR MOVE-IN DATE OR ON DAY OF MOVE IN.
